1. Purpose of Report

1.1. The purpose of the report is to:-

- provide information on the actual expenditure measured against the revenue budget for the period 1 April 2010 to 29 October 2010 for Clyde Valley Learning and Development
- provide a forecast for the year to 31 March 2011

 - (1) that the net expenditure on Clyde Valley Learning and Development Joint Committee revenue budget of £0.165million, as detailed in Appendix A of the report, and the forecast to 31 March 2011 of break even be noted.

3. Background

- 3.1. This is the third revenue budget monitoring report presented to the Clyde Valley Learning and Development Joint Committee for the financial year 2010/2011. Further reports will follow throughout the financial year.

5. Financial Implications

5.1. As at 29 October 2010, the net expenditure to date is £0.165 million, showing a break even position against phased budget. The financial forecast to 31 March 2011 is a break even position.

6. Other Implications

6.1. The main risk associated with the Clyde Valley Learning and Development Joint Committee Revenue Budget is failure to manage the budget resulting in expenditure exceeding available funding. The risk has been assessed as low given the detailed budget management applied within the Joint Committee. The risk is managed through four weekly Budget Monitoring Meetings at which any variance is analysed.

In addition, the probable outturn exercise ensured early warning for corrective action to be taken where appropriate.
